INVESTMENT OBJECTIVE AND POLICY

The Cannon Money Market H4 Fund aims to generate income in excess of short-term bank deposit rates while preserving capital with a minimal level of volatility and a high level of liquidity. It is a low-risk fund. Capital gains will be incidental in nature. The portfolio will comprise of money market instruments as defined by the Collective Investment Schemes Control Act 45 of 2002 and will be managed in accordance with prudential guidelines governing pension funds. The manager may vary the proportions of securities in the portfolio due to the changing of economic factors or market conditions or retain cash in the portfolio and/or place cash on deposit. The portfolio will be allowed to invest in financial transactions for the swap of interest rates where the inclusion of such a transaction is used for the purpose of efficient portfolio management only.

RISK REWARD PROFILE



Given the nature of its investments, this portfolio is allocated the lowest risk rating in terms of the above risk reward profile, but it is not a risk-free investment. It could be affected by adverse changes in macroeconomic and interest rate conditions, as well as in the credit worthiness of the money market instrument issuers. 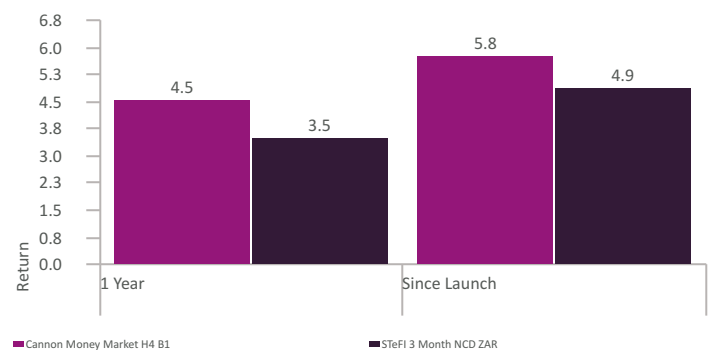

FUND COMMENTARY

Most global equity markets, including South Africa, had a positive July with the FTSE/JSE All Share Index recording a strong gain of 4.2%, mainly driven by commodity, metals and materials counters. The country grappled with the most devastating riots, looting and unrest during the month which will live long in memory. It was largely felt in Kwazulu-Natal (KZN) as well as certain parts of Gauteng. The consequences of the looting and rioting seem certain to set the country's fragile economy back and further slow the recovery from the pandemic. In local economic news, annual headline inflation fell to 4.9% year-on-year in June, compared to 5.2% in May, as measured by the consumer price index (CPI). This was marginally higher than consensus expectations of 4.8% year-on-year. At its July meeting, the SA Reserve Bank (SARB) kept interest rates unchanged at 3.5% as expected; with the tone of the statement seemingly dovish. The SARB estimates that the better Q1-21 growth was fully negated by the unrest, resulting in an unchanged GDP growth estimate of 4.2% for 2021.

The Cannon Money Market H4 Fund ('the fund') returned 0.3% for July, slightly ahead of the benchmark. The outlook for inflation and the path of interest rates continues to change, however, we have positioned the fund to balance the split between both fixed and floating rate investments. The fund continues to adhere to its policy

About the manager, trustee and scheme

This portfolio was established by H4 Collective Investments (RF) (Pty) Ltd, registration number 2002/009140/07 ("the manager") of The Citadel, 15 Cavendish Street, Claremont, 7708 (telephone +27 21 670 9100) as part of the H4 Collective Investments Scheme ("the scheme"). The trustee of the scheme is the Standard Bank of South Africa Limited of 9th Floor, Standard Bank Centre, 5 Simmonds Street, Johannesburg, 2001 (telephone +27 11 636 9111/2).

About the investment manager

The manager has appointed Cannon Asset Managers Proprietary Limited, registration number 2000/025176/07 ("Cannon"), as the investment manager of the portfolio. Cannon is licensed as a financial services provider in terms of the Financial Advisory and Intermediary Services Act, 2002.

Risk warning

The risk and return profile of a fund illustrates the amount of risk undertaken by an investor in the hope of achieving a particular return on an investment. Disclosures in respect of the Cannon Equity H4 Fund

The Cannon Equity H4 Fund was originally established as the Cannon MET Equity Fund under the MET Collective Investments Scheme. The Cannon Equity H4 Fund was established under the H4 Collective Investments Scheme on 30 September 2016 and amalgamated with the Cannon MET Equity Fund on 3 February 2017. The amalgamated portfolio continued under the name of the Cannon Equity H4 Fund. The Cannon Equity H4 Fund charges a performance fee of 15% of the excess total return above the FTSE/JSE All Share Total Return Index over a rolling 1-year, capped at 1% p.a. The performance fee is calculated daily and deducted monthly on a high-water mark principle.

Disclosures in respect of third-party-named portfolios

This portfolio is a third-party-named portfolio. A third-party-named portfolio bears the name of both the manager and the investment manager. The manager retains full legal responsibility for the third-party-named portfolio.

Disclosures in respect of the Cannon Money Market H4 Fund only

A money market portfolio is not a bank deposit account. The price of participatory interests is targeted at a constant value. The total return to the investor is made up of interest received and any gain or loss made on any particular investment, and in most cases the return will merely have the effect of increasing or decreasing the daily yield, but in the case of abnormal losses it can have the effect of reducing the capital value of the portfolio. Excessive withdrawals from the portfolio may place the portfolio under liquidity pressures – in such circumstances a process of ring-fencing of withdrawal instructions and managed pay-outs over time may be followed. The yield is calculated monthly as at the date stipulated on the face of this document, using historical figures and is annualised.

Calculation of the NAV and price

The value of participatory interests is calculated on a NAV basis. The NAV is the total value of all assets in the portfolio including any income accruals and less any deductible expenses (which may include audit fees, brokerage, service fees, securities transfer tax and bank charges). The price of participatory interests is calculated by dividing the NAV by the number of participatory interests in issue. Prices are published daily in local newspapers. The portfolio is available via certain LISPs, who levy their own fees. Investors in this portfolio may thus be liable for an initial fee and/or annual service fee levied by the third party administrator that is not reflected in the initial charge (where applicable) or NAV calculation.
