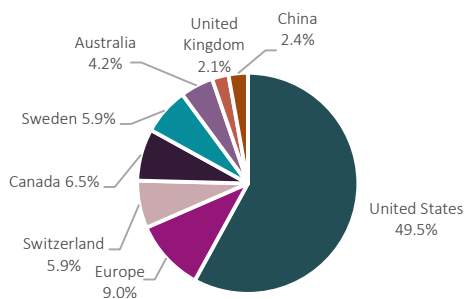
INVESTOR PROFILE

STRATEGY AND OBJECTIVES

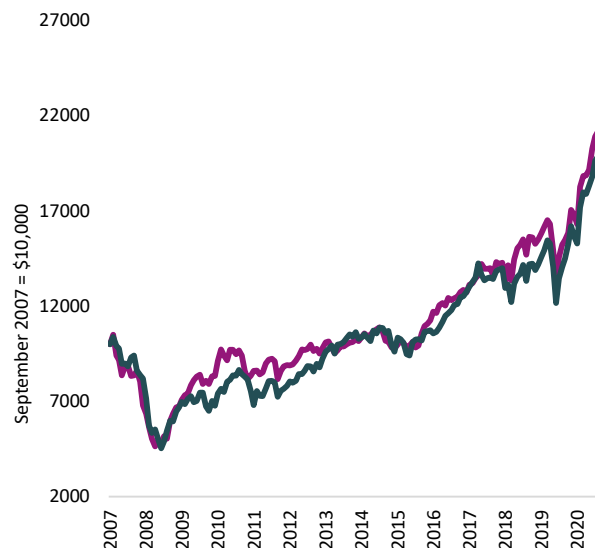
