STRATEGY AND OBJECTIVES

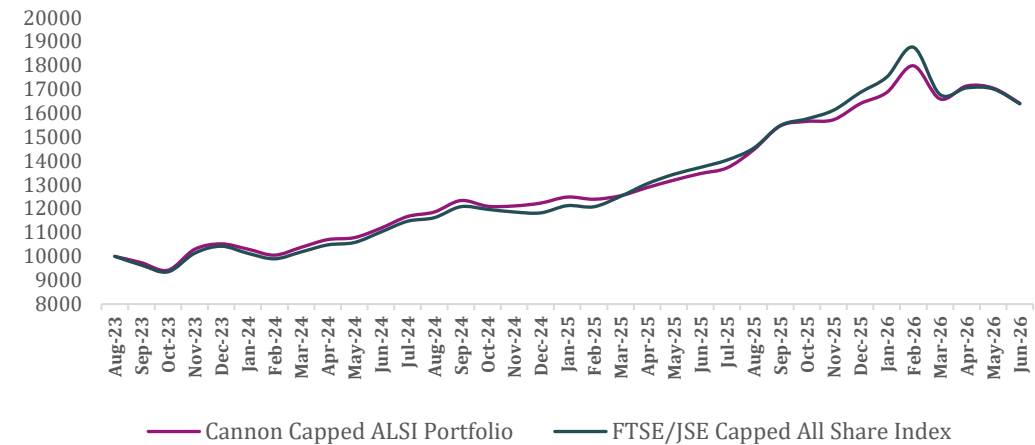
The Capped SWIX Portfolio aims to create long-term wealth for investors. The portfolio manager follows a rigorous, time-tested stock selection process and investment philosophy.
